



I hope you are well.

The March – June quadrimester of 2020 brought us unexpected negative developments. The sudden appearance of the coronavirus COVID-19 and its rapid spread brought hundreds of thousands of deaths and millions of cases worldwide. The coronavirus pandemic not only caused the loss of human lives but also led to huge financial losses, billions in damage, worldwide. The coronavirus has

radically changed our daily lives and, unfortunately, until a vaccine is found, which is not forecasted for months, we will have to learn to live with it.

Of course, our small Cyprus could not be left untouched by the effects of the pandemic. Dozens of people have died with the final cause of death being the coronavirus, around 1000 (a thousand) cases and millions in financial losses. The closure of airports, businesses and almost all types of economic activity has had a significant impact on the local market.

There are several adverse factors that we are required to manage as a state and as a society. In addition to ensuring health, which is our top priority, we must show patience, courage and ingenuity, all three at a personal as well as at a professional level. And we will come out winners. Moreover, we have done it again in the past in similar crises.

With the closure of construction sites for about a month and a half, the construction industry has been hit hard. But we are called upon to react, to endure, and to lead the construction industry, which is the backbone of the local economy, back to growth. In cooperation with the government, the relevant professional bodies and organisations, we must strive to implement these strategies that will help us to effectively manage the crisis and will lead us again to success.

It is up to us!

And I'm sure that with hard work, we will be able to look again, very soon, to the future with optimism

Since the first cases of COVID-19 were confirmed in Cyprus on 9 March 2020, the Cypriot government took swift action against the coronavirus pandemic with the implementation of governmental decrees and informational guidelines. This included a six-week coronavirus lockdown in Cyprus of all construction projects considered non-essential. In this rapidly evolving COVID-19 environment, large contractors like us are challenged to ensure smooth operations while protecting the health of our employees, clients, business partners, and our community. In times like these, it is critical to have a well-thought-out plan that is flexible enough to deal with a variety of possible scenarios.



We are addressing the current situation by concentrating our efforts into the following three major categories:

- Risk mitigation: risk mitigation if operations are impacted
- Prevention: prevention of COVID-19 within our operations
- Monitoring: monitoring and response as events change





#### **Risk mitigation**

A COVID-19 Risk Assessment was undertaken for each of our construction sites to address and mitigate any COVID-19 risks associated with each construction site. In addition, the emergency action plans for each construction site/office/facility was updated to consider emergency situations associated with the coronavirus, e.g., a suspected coronavirus case at the workplace.

The COVID-19 Risk Assessment deals with several issues including the following:

- Travelling to and from the worksite
- Site Access and Egress Points for Personnel and Visitors
- Movements within the construction site
- Washing Hands
- Welfare Facilities Toilets
- Rooms / Dining and Rest Areas
- First Aid

- Site meetings
- Monitoring and tracing of staff for COVID-19
- Social distancing / PPE (Personal protective equipment)
- Close working at a distance less than 2m
- Suspected coronavirus case at the worksite
- Exposure to COVID-19 while working from home or away from work



We have implemented a leadership response team that will provide enterprise direction in the event of a coronavirus lockdown or other changes to governmental decrees / informational guidelines.





#### Prevention

We are implementing governmental COVID-19 decrees and informational guidelines, such the Department of Labour Inspection's "Health and Safety at Construction Sites: Covid-19 Pandemic Management Guide", including:

- Stop all non-essential visitors to our construction sites/offices/facilities.
- All employees have their temperature taken and be observed for symptoms of the coronavirus before entering our construction sites.
- Ensure the number of people inside the construction site is reduced as much as possible.
- Minimum number of persons occupying offices, site offices, conference rooms, eating areas and other rooms/areas so that the 2m "social distancing" rule is obeyed at all times.
- 2m minimum distance to be kept from others where possible ("Social distancing")
- Use of PPE when 2m minimum distance can not be maintained between employees.
- Increase the number of hand washing facilities and/or alcohol-based hand sanitisers at our construction sites/offices/facilities.
- Follow the Ministry of Health's cleaning guidelines for the prevention of COVID-19.
- Institute enhanced cleanliness efforts for common surfaces and areas like eating areas, toilets, doorknobs, workstations, etc.
- Require operators at our construction sites to wipe down equipment controls with effective hospital grade disinfectants.
- Implement a procedure for a suspected coronavirus case at the workplace.

We are also educating our employees to prevent spread. We are using briefings, posters, and electronic communications to encourage:

- Staying home when sick.
- Immediately contacting the Ministry of Health (phone number: 1420) and their personal physician if showing symptoms of the coronavirus.
- Informing his/her employer if he/she experiences symptoms of COVID-19 coronavirus or has come into contact with a confirmed case of COVID-19 coronavirus out of work.
- Safe cough and sneeze protocols, including covering the mouth and nose with a bent elbow or tissue when coughing or sneezing.
- Hand hygiene, including both 20-second-minimum hand washing and sanitiser use.
- If the employee has a positive COVID-19 diagnosis, must inform his/her employer immediately. The employee can return to his work only after he has fully recovered, with a doctor's note confirming his/her recovery.



We have and are deploying adequate stores of paper towels, soap, hand sanitizer, and tissues. We are encouraging healthy measures, asking our employees to:

- Minimize touching of other people, including handshaking.
- Avoid touching their faces, noses, and mouths.
- Maintain a 2 metre distance from those who are coughing or sneezing.

We are enacting temporary policies to accommodate safer behaviour to protect our employees. For example, we have eliminated business travel as much as possible. We are focused on a healthy workplace so we will rely on technology more to hold meetings using Microsoft Teams or similar videoconferencing and teleconferencing software. In addition, we have put in strict policies to limit visitors to our facilities.

We are also temporarily adjusting time-off policies for employees to take care of themselves or family members in accordance with governmental decrees.



#### Monitoring

We actively monitor the latest information on the coronavirus (COVID-19) outbreak, including reports and travel advisories from the Cypriot government and the WHO. Additionally, we work with the health authorities in Cyprus and are monitoring the spread of COVID-19 in real time. Based on that information we adjust our operational plans accordingly.

In accordance with a governmental decree, we also have tested employees at our sites and warehouse for COVID-19 and, to date, all tests were negative.



As you can see there are many parts to a well-thought-out operations plan, but the most important pieces are communication and transparency. Regular updates and honest conversations with employees, partners, and clients are critical to ensure the best outcome for all parties.

### Limassol Del Mar, Limassol

#### Start date: March 2018

Project Description: Less than 25m from the beach, we have begun constructing this project, on a plot of 34,000m2 with its south side offering 170m of unobstructed sea views. Inspired by the gentle and curved waves of the Mediterranean in the south and from the low hills to the north, the unique sinusoidal curves of the project appear both in its center and on the floors with the curved walls creating a separate sculpture of approximately 40,000m2. Clearly influenced by nautical architecture, the building reflects a large cruise ship, with the outer gardens of the summit standing proudly as the bridge and the command station. The first construction phase involves the delivery of the first two towers (A and B), 13 and 18 floors respectively. The second phase involves the delivery of the apartments of the "Signature Collection", that is the eastern tower of 28 floors. All the floor slabs for the towers of the first phase are completed. Currently works for the towers of the first phase include finishing works (dry wall partition works, aluminium works, floorings, carpentry, and sanitary installation works). With regards to the second phase, we have completed the 13th floor slab. External works have just started and currently include underground services works.

### Sky Tower, Limassol

#### Start date: October 2018

Project Description: Project Description: Luxury high-end apartments on a 23-store tower with hotel amenities that is being developed with the latest architectural and design trends. Situated only 300m from the sea, the apartment owners can enjoy the vast amenities of the facilities that among others include incredible panoramic sea views, relaxing spa breaks, shared outdoor pool, heated indoor pool, fitness centre, tennis court, fantastic evergreen gardens surrounding the tower and spacious underground parking. Sky Tower rests harmoniously on the cityscape of the Limassol tourist area thanks to its magnificent design by one of London's leading architectural agencies. This 23-store challenging project will have aluminium coating all over the outside. One of the remarkable things about this construction is that the floor slabs, unlike the conventional ones, are post-tensioned. The post-tensioned slabs are designed to provide active reinforcement, making the building blocks even more efficient in terms of stability and economy in building materials. Moving with steady steps towards completion, works are currently executed on the top floor. The current works also include finishing works (dry wall partition works, aluminium works, floorings, carpentry, and sanitary installation works). Project's external works have also started. The project is being developed on behalf of Prime Property Group.

The building consists of 18 stylish and modern 1, 2, and 3-bedroom apartments separated into 2 apartment blocks. Block A has 2 floors and 8 apartments. ### Ararat Grand Residences, Limassol

#### Start date: December 2019

**Project Description:** Luxury high-end apartments on a 23-store tower with hotel amenities. The project is being developed along the beach road of Parekklisia area, in one of the most prestigious areas of Limassol. This unique high-rise building consists of only 17 luxurious apartments and a 5-floor penthouse. At road level there is a grand plaza leading to a gourmet restaurant, professional SPA, sauna, hammam, massage room, heated pool in a cave style enclosure, cigar lounge and a VIP bar for club members, wine cellar and jewelry boutique. At this level there is also a parking for residents as well as a separate parking for restaurant and commercial area visitors and guests. On the first floor there is the entrance lobby and reception on two levels. On the grounds of the complex (about 8.000 m2) there is a half-Olympic size (25x10m) mosaic swimming pool with a bar, tennis court, park, and a playground. The project's grounds are enclosed with a secure fence, and a 24-hour video surveillance. The rest of the building consists of the following:

- 3rd and 4th floor: apartments.
- 5th floor: sauna and gym.
- 6th floor: Roman bath style heated indoor swimming pool with a bar breakfast and recreation area.
- 7th -12th floor: apartments.
- 13th floor: Sky Garden, which is part of the restaurant on the next floor.
- 14th storey: a fine dining restaurant which has a separate elevator and parking area.
- 15th -18th floor: apartments.
- 19th-23rd floor: penthouse apartment with its own elevator and a swimming pool.

Regarding the progress of works, earthworks and foundation works of the main building are concluded. Currently the works include column works for the main building and preparatory works for all the external areas of the project.

#### Mr Tonis Toumazis statements on StockWatch

The founder of **Atlas Pantou** and **Atlas Panton** groups gave statements to the financial online portal **stockwatch.com.cy**. Below are his statements as published on the StockWatch website on May 27th:

Promoting of a larger number of public sector projects, as compensation for the loss that contractors may undertake due to the suspension of new projects in the private sector, is demanded by many of the sector's participants.

The founder of Atlas Pantou group, Mr. Tonis Toumazis, said in a statement to StockWatch that "the government should promote projects to keep the construction sector at a satisfactory level", while noting that "large private projects will take further time until they enter their implementation phase".

Mr. Toumazis opinion is that the tourist and the construction and land development sectors, that strongly rely on foreign investors, will have a great respite until sales return to satisfactory levels.

He noted that "how fast sales in high-rise buildings will pick up is going to become clear in the coming months when foreign investors, on which this market strongly relies on, show whether they overcame the phobia created by the unprecedented COVID-19 pandemic."




#### Mr.Tonis Toumazis Birthday


