

THE 80 YEARS ANNIVERSARY BOOK


With origins dating back to 1937, Atlas Pantou has been an important asset in the Cyprus construction industry. We feel that it is time to give something back to our country, our culture and our education.

Start date: May 2015

Delivery Date: August 2018

Project Description: Located on 100,000m2 of waterfront land and consists of 53 suites, most with their own private pools, and 222 luxury guestrooms. Among the extensive facilities on offer, is a 2,000m2 conference centre with a state-of-the-art 1,000m2 theatrical Ballroom, 5 restaurants, 2 bar outlets, a 2,700m2 spa and 3 outdoor swimming pools one of which is a seawater pool.

Larnaca Sewer (C18)

Start date: August 2016

Delivery Date: November 2018

Project Description: Supply and Installation of sanitary sewers, pumping stations and associated works. The project included installation of 27 Km of sewerage line with house connections and installation of 3 pumping stations (2 for sewerage and 1 for stormwater).

The project took place in the Kamares area of Larnaca.

Limassol Del Mar, Limassol

Start date: March 2018

Project Description: Less than 25m from the beach, we have begun constructing this project, on a plot of 34,000m2 with its south side offering 170m of unobstructed sea views.

Inspired by the gentle and curved waves of the Mediterranean in the south and from the low hills to the north, the unique sinusoidal curves of the project appear both in its center and on the floors with the curved walls creating a separate sculpture of approximately 40,00m2. Clearly influenced by nautical architecture, the building reflects a large cruise ship, with the outer gardens of the summit standing proudly as the bridge and the command station.

The first construction phase involves the delivery of the first two towers (A and B), 13 and 18 floors respectively. The second phase involves the delivery of the apartments of the "Signature Collection", that is the eastern tower of 28 floors.

Up to now, we have completed the 9th floor slab for the towers of the first phase. With regard to the second phase, we have completed the ground floor foundation and piling works and we have begun the 1st floor slab.

Sky Tower, Limassol

Start date: October 2018

Project Description: Luxury high-end apartments on a 23-store tower with hotel amenities that is being developed with the latest architectural and design trends. Situated only 300m from the sea, the apartment owners can enjoy the vast amenities of the facilities that among others include incredible panoramic sea views, relaxing spa breaks, shared outdoor pool, heated indoor pool, fitness center, tennis court, fantastic evergreen gardens surrounding the tower and spacious underground parking.

Sky Tower rests harmoniously on the cityscape of the Limassol tourist area thanks to its magnificent design by one of London's leading architectural agencies.

This 23-store challenging project will have aluminum coating all over the outside. Moving with steady steps towards completion, work is currently being done on the 12th floor.

The remarkable thing about this construction is that the floor slabs, unlike the conventional ones, are post-tensioned. The post-tensioned slabs are designed to provide active reinforcement, making the building blocks even more efficient in terms of stability and economy in building materials.
